Activity Waiver

IN CONSIDERATION of myself and/or my child being permitted to participate in any way in the sports, recreation, and/or fitness activities at the BCOG, I, for myself, and for my personal representatives, and next of kin:

1. I ACKNOWLEDGE, agree, and represent that I understand the nature of the Activity or Activities and that my child is in good health, and in proper physical condition to participate in the Activity or Activities at the BCOG. I further agree and warrant that if at any time I believe conditions to be unsafe, I will immediately discontinue my participation and/or my child's participation in the Activity or Activities.

2. I FULLY UNDERSTAND THAT:

(a) THE ACTIVITY or ACTIVITIES MYSELF or MY CHILD WILL BE INVOLVED IN MAY INVOLVE AGGRESSIVE PHYSICAL SPORT ACTIVITY or ACTIVITIES THAT COULD POSSIBLY CAUSE SERIOUS HEALTH RISKS AND/OR DANGER OF BODILY INJURY(S).

(b) these RISKS and dangers may be caused by myself or my child's own actions or inactions, the actions or inactions of others participating in the Activity or Activities, the condition(s) in which the Activity or Activities take(s) place, or THE NEGLIGENCE OF THE "RELEASEES" NAMED BELOW;

(c) There may be OTHER RISKS AND SOCIAL AND ECONOMIC LOSSES either not known to me or not readily foreseeable at this time; and I FULLY ACCEPT AND ASSUME ALL SUCH RISKS AND ALL RESPONSIBILITY FOR LOSSES, COSTS, AND DAMAGES I incur as a result of my participation, or that of the minor I represent, in the Activity or Activities.

HEREBY RELEASE, DISCHARGE, AND AGREE NOT TO SUE THE BLACKSHEAR CHURCH OF GOD, its owners, administrators, directors, agents, officers, members, volunteers, and employees, other participants, sponsors, advertisers, and, if applicable, owner and lessors of premises on which the Activity or Activities take(s) place, FROM ALL LIABILITY, CLAIMS, DEMANDS, LOSSES, OR DAMAGES ON MY ACCOUNT CAUSED OR ALLEGED TO BE CAUSED IN WHOLE OR IN PART BY THE NEGLIGENCE OF ONE OR MORE OF THE RELEASEES OR OTHERWISE, INCLUDING NEGLIGENT RESCUE OPERATIONS AND I FURTHER AGREE that if, despite this RELEASE AND WAIVER OF LIABILITY, ASSUMPTION OF RISK, AND INDEMNITY AGREEMENT I, or anyone on my behalf, makes a claim against any of the Releases, I WILL INDEMNIFY, SAVE, AND HOLD HARMLESS EACH OF THE RELEASEES from any litigation expenses, attorney fees, loss, liability, damage, or cost which any may incur as the result of any such claim. I HAVE READ THIS AGREEMENT, FULLY UNDERSTAND ITS TERMS, UNDERSTAND THAT I HAVE GIVEN UP SUBSTANTIAL RIGHTS BY SIGNING IT AND HAVE SIGNED IT FREELY AND WITHOUT INCENTIVE OR ASSURANCE OF ANY NATURE AND INTEND IT TO BE A COMPLETE AND UNCONDITIONAL RELEASE OF ALL LIABILITY TO THE GREATEST EXTENT ALLOWED BY LAW AND AGREE THAT IF ANY PORTION OF THIS AGREEMENT IS HELD TO BE INVALID, THE BALANCE, NOTWITHSTANDING, SHALL CONTINUE IN FULL FORCE AND EFFECT.
